# VFW 101

## Levels of Organization



National Organization	There is 1	Led by National Commander in Chief
Departments	There are 52	Led by Department Commanders from the 50 States, Department of Europe and Department of the Pacific
Conferences	There are 4	Led by Conference Chairman from Western Conference, Southern Conference, Eastern Conference and the Big 10 Conference
Districts in Washington	There are 13	Led by District Commanders from the 13 Districts
Posts in Washington	There are 106	Led by Post Commanders from the 106 Posts



# VFW 101

## Membership Types



Annual Member

Pays Dues Annually

Has voice on the floor of all levels of meetings as long as membership dues are current and remains member in good standing

Life Member

Life Member Dues Paid

Has voice on floor of all levels of meetings as long as remains member in good standing

Legacy Life Member

Bronze, Silver, Gold Levels  
\$400 cost for each level

Remains on Rolls after death, Post and Department receive annual funds in members name forever.

Member at Large

Both Annual and Life membership options

can use any Post Home facility as long as dues are current and remains member in good standing. Has no Voice on any level of meetings



# VFW 101

## GAVEL RAPS



The Commander at Post, District, Department, National levels, a Conference Chairman, or Committee Chairman control the meeting by use of a Gavel.

Several Raps of Gavel	Used to get attention of the membership
2 Raps of Gavel	Used to get all membership to stand during meeting
1 Rap of Gavel	Used to call to order, declare meeting open, declare recess, declare adjourned, declare meeting closed
1 Rap of Gavel	Used during meetings after completion of a business item
1 Rap of Gavel	Used to seat all members during meeting or to maintain order



# VFW 101

## *Speaking*



In meetings of units of this Organization

members holding office shall be addressed as “Comrade” followed by the title of officer they hold

All other members shall be addressed as “Comrade”



# VFW 101

## Speaking



Only members of a Post with current dues paid and in good standing may speak during a meeting, members at large have no voice on the floor and cannot be recognized to speak.

First Step is to Stand to be recognized by the Chair or Commander

Only after being recognized by the Chair or Commander, address the Chair or Commander

Start statement or question with: Salute - Mr Chairman or Madam Chairman and who you are

Salute - Comrade Commander and who you are

if addressing another individual: Salute - Mr Chairman or Madam Chairman and Who you are

thru you to the other individual then statement or question

Salute - Comrade Commander and who you are thru you to the other individual then statement or question



# VFW 101

## *Motions*



Motions are the Action of our organization and how business is conducted

We use Motions to approve the spending of funds for programs and events  
(Motion to use \$100 for the Kids Christmas Party, Motion to donate \$100 to Unmet needs)

We use Motions to approve doing events and programs  
(Motion to allow Scout Troop the use of the Post Home, Motion to hold a fundraiser)

We use Motions to create or end programs  
(Motion to create an Adopted Unit Team to coordinate events, Motion to end the Youth Baseball Team Post Program as there is no longer a team in the community to sponsor)





# VFW 101

## *Motions*



Only members of a Post with current dues paid and in good standing may make a motion during a meeting, members at large have no voice on the floor and cannot make a motion.

Follow steps covered for speaking on the floor

Only after being recognized by the Chair or Commander, address the Chair or Commander

Mr Chairman or Madam Chairman or Comrade Commander and who you are

I make a motion and what it is

Another member must 2<sup>nd</sup> the motion or it fails due to lack of 2<sup>nd</sup>

Once motion is made and proper 2<sup>nd</sup> it is open for discussion by all

After discussion, the Chairman or Commander Calls for a vote

Chairman or Commander gives results of vote (pass or fail)



# VFW 101

## Funds



We have two types of funds in the VFW

Unrestricted Funds: Commonly referred to as General Funds

These funds are used for the day to day operations of the Post Home such as utilities

These are also the funds the membership can request to be used for a variety of programs, events, projects, or whatever they would like to request as they are unrestricted in use



# VFW 101

## Funds



### Restricted Funds:

These are earmarked funds that can ONLY be used a specific way or for a specific program.

The Relief Fund is the most common one, as these funds are restricted for use in accordance with our National Bylaws (Veterans Relief, Youth Education, Troop Support are some examples)

These funds are voted on by the membership for expenditure

Any Specific Program could have its own restricted funding to account for the funds and ensure these funds are used only in that capacity (Holiday Food Basket Fund is an example of a restricted use line item tracking of funds coming in that can only be used specifically for that Purpose)

These funds are also voted on by the membership for expenditure



# VFW 101

## Funds



When making motions to use funds, you must make sure that you are clear on where these funds are coming from as well as making sure that the funds requested can be used for that purpose.

If you feel that restricted funds are not being used properly, bring it up under discussion or make a motion to amend the motion to use funds from the appropriate line item, either specific to that program or from the General Fund.



# VFW 101

## Meeting Types



### Post Meetings

Monthly Post Meetings in accordance with your Post bylaws on the dates and times scheduled

This is where the monthly reports are given, upcoming programs and events are planned, and Post Business is conducted by the membership. This is where your voice is important, if you want your post to do more events or less events or focus on this program or end a program or change directions, this is where you bring your ideas and present them for the membership to hear your voice and either approve or disapprove your recommendations. We can't move forward with new ideas if they are not brought up, and the Post meeting is the best place to do this. Bring up putting a kid's area in a corner of your Post Home or doing a family or kid focused event quarterly at the Post home. You may be asked to Chair the Committee, but who better to work on a project than the person who had the idea.



# VFW 101

## Meeting Types



### Post Special Meeting

If an emergency situation comes up between the schedule monthly meetings, the commander can notify the membership of the need for a Special Post Meeting to handle the situation. This meeting can be conducted by quorum specific to you Post bylaws. The minutes of the meeting must be read into the next Post Meeting.

By written request of 7 members

By majority vote of membership present at Post meeting



# VFW 101

## Meeting Types



Quorum

Simply put a Quorum is the minimum number of membership present to be allowed to conduct business. In no case will the Quorum be less than 5 members



# VFW 101

## Meeting Types



### District Meeting

Districts will hold at least 2 regular meetings each year for purposes of transacting business and conducting schools of instruction

### District Convention

District shall hold an annual District Convention for the purpose of electing District Officers not less than 10 days nor more than 75 days prior to the convening of the Department Convention

## Meeting Types



Western Conference

Meets 2 a year  
1<sup>st</sup> Weekend in November  
At National Convention

# VFW 101

## *Internal Organizations*



### Military Order of the Cooties

Is a National Honor Degree membership association separately constituted as a subordinate and an auxiliary order chartered by the VFW

Governed by and subject to jurisdiction of the National Convention of the VFW, Commander in Chief VFW, National Counsel of Administration VFW, Grand Put Tents, Pup tents, respective Department Convention, Department Commander, Department Counsel of Administration or Post

MOC is authorized to establish an Auxiliary (MOCA) but only after approval by the Post with which it is affiliated



# VFW 101

## *Internal Organizations*



### VFW Auxiliary

Assist the VFW in Programs and Events

Have their own bylaws and Rules

Operate on their own and report Auxiliary Officers make such reports as may be required in the Manual of Procedure

Have their own Charter and may issue Charter at all levels from Post to Department

Persons eligible for Auxiliary are limited to spouses, parents, grandparents, brothers, sisters, children, and grandchildren of a person who was or is eligible for membership in the Veterans of Foreign Wars of the United States

Persons eligible for membership in the Veterans of Foreign Wars of the United States are NOT eligible for membership in the Auxiliary.



# VFW 101

## *Internal Organizations*



### Military Order of the Cooties and Auxiliary

- Eligibility:
- member in good standing past 6 months
  - completed satisfactory service on a major Post Committee
  - satisfactorily performed Post duties or participated actively as a leader of Post functions
  - been approved for membership by a majority vote of the membership present and voting at a meeting of the Post

Follow National Statement of Policy for VFWRG

MISSION To promote and support the programs of the Veterans of Foreign Wars

# VFW 101

## *Internal Organizations*



### VFW Riders Group

#### VFWRG MEMBERSHIP

The Veterans of Foreign Wars Motorcycle Riders Group is a motorcycle group made up of members in good standing of the Veterans of Foreign Wars (VFW), VFW Auxiliary and invited participants who enjoy the pastime of motorcycling.

Members and participants must be the legally registered owner of a street-legal motorcycle and must possess a valid motorcycle driver's license in their state of residence, and maintain proper levels of insurance; or passenger thereto; or non-riding persons volunteering on behalf of the group in an active supporting role.



# VFW 101

## *Internal Organizations*



### VFW Riders Group

#### VFWRG MEMBERSHIP

Participants: Persons, otherwise not eligible for the VFW or VFW Auxiliary, will be permitted to become VFWRG participants provided such policy is adopted by the sponsoring unit.

Such participant classification does not constitute membership in the VFW or VFW Auxiliary nor come with the promise of any material, financial, or other benefit to the VFWRG, its members or committee; nor to any other member at any other organizational level within the VFW or VFW Auxiliary; nor will there be any similar gains for the honoree through the conferring of "participant" status, but is intended as a means to provide recognition to those who show strong support to the VFW/VFWRG stated purpose.



# VFW 101

## *Internal Organizations*



### VFW Riders Group

#### VFWRG MEMBERSHIP

Persons, otherwise not eligible for VFW or VFW Auxiliary, who subsequently become eligible for VFW or VFW Auxiliary membership, must join.



# VFW 101

## *Internal Organizations*



### VFW Riders Group

#### BYLAWS/STANDARD OPERATING PROCEDURES/ADOPTED RULES & REGULATIONS

Sponsoring units shall establish Bylaws, a standard operating procedure, or adopt additional rules and regulation for the governance of their VFWRG. Such Bylaws, procedures, or rules shall be subordinate to and consistent with the Bylaws of the sponsoring unit.



# VFW 101

## *Internal Organizations*



### VFWRG Riders Group

#### REPORTING

VFWRG's shall make a monthly report to its sponsoring unit.

VFWRG's will report annually to the National VFWRG Advisory Committee

A full accounting of VFWRG members and participants to include VFW Members, VFW Auxiliary Members, and invited participants.

Their activity, which should include a number of VFWRG events, mileage, and hours.

An accounting of funds raised and disbursed by the VFWRG for the year.



# VFW 101

## *Rules of Order Governing All Meetings*



Procedural matter not provide for in the Bylaws shall be governed by the current Robert's Rules of Order, Newly Revised.

These rules may be altered or amended at any regular session of the body, upon proposition in writing, and by a majority vote of those present and voting. Any alteration or amendment of the rules provided in the Bylaws shall be in accordance with procedures provided or permitted by Robert's



# VFW 101

## *Rules of Order Governing All Meetings*



All Questions shall be presented and determined upon motion. A motion must first be properly presented and seconded, and then stated by the presiding officer, before it can be open to debate or amendment, or any further action upon it.

Simply put

Must be a motion put on the floor, a proper second, and then motion restated by the presiding officer before there can be discussion, amendments or voting

Most Common issues- Someone makes a motion and then someone else gets up and talks about it or recommends changes, that is not how business is conducted. If done orderly and properly good debates for and against can happen, amendments to change motion can happen and what is best for organization prevails



# VFW 101

## *Rules of Order Governing All Meetings*



### Withdrawing a motion

by the mover alone before the question has been completely stated by the presiding officer

by the mover after the presiding officer has stated the question, provided no member of the body objects

by majority vote of the body after the presiding officer has stated it, regardless of objection

After a motion has been carried it can be withdrawn only by unanimous consent

A withdrawn motion is NOT recorded in the minutes





# VFW 101

## *Rules of Order Governing All Meetings*



Not more than one primary and one secondary amendment can be before the body at one time

Any number of amendments can be successively proposed when there has been a disposition of either or both pending amendments

If two amendments are pending, the secondary amendment is first put, then the primary amendment (as amended, if the secondary amendment prevails)

The amendment is always put first

The main motion must be put regardless of the action taken on amendments



# VFW 101

## Rules of Order Governing All Meetings



Simplified

Motion is made to spend \$200 on stand down

Motion to amend the \$200 to \$400 dollars is made

secondary motion to amendment to add \$100 to amendment for a total of \$500

first vote is on secondary amendment

voted on and approved to add the 100 to amendment

next vote is on amendment with secondary amendment added

voted to approve amendment as amended

next vote is on original motion as amended

(Motion to spend amended \$500 on stand down)



# VFW 101

## *Rules of Order Governing All Meetings*



Rising to speak on a motion

member shall rise and address the presiding officer

when two or more members rise to claim the floor at about the same time, the presiding officer assigns the floor to the member who appeared to have risen first and addressed the chair

a member having the floor shall confine their remarks to the question before the body



# VFW 101

## Rules of Order Governing All Meetings



Rising to speak on a motion

simplify:            rise to speak  
                         salute presiding officer  
                         get presiding officer permission to speak  
                         address the membership on the question only – no sidebar speech  
                         salute presiding officer  
                         be seated



# VFW 101

## *Rules of Order Governing All Meetings*



Rising to speak

On a Motion

No member shall speak more than twice on the same question

No member shall speak longer than 10 minutes each time

No member shall speak a second time on the same question if any member who has not spoken on that question arises to claim the floor to speak thereon.

Nominating speeches

shall not exceed 5 minutes each, nor exceed two seconding speeches of two minutes each



# VFW 101

## *Rules of Order Governing All Meetings*



### Debating

No member shall in debate, impeach the motives of a fellow member or treat them with disrespect.

Members shall avoid personalities and unbecoming speech

a member shall not pass between the speaker and the chair



# VFW 101

## *Rules of Order Governing All Meetings*



### Debating

any conversation calculated to disturb a member while speaking or hinder the transaction of business, shall be deemed a violation of order and, if continued, the offending member shall be reprimanded by the presiding officer and may be ordered to retire from the room

failure to comply with an order to retire may subject a member to disciplinary action for conduct prejudicial to the good order and discipline

When a member is called to order for disorderly conduct or abusive language, if such conduct is not immediately stopped and an apology immediately proffered by said member, disciplinary action may be taken against such member



# VFW 101

## *Rules of Order Governing All Meetings*



### Interruptions

No member shall be interrupted while speaking except by a call to order which shall be forthwith ruled upon by the presiding officer as being either “well taken” or “not well taken”

When a question of order is raised, the interrupted member shall forthwith take their seat until the point of order is decided

No member shall be interrupted while speaking on account of misstatements spoken in debate, but they may be answered, corrected, or explained when the member has finished speaking.





# VFW 101

## Rules of Order Governing All Meetings



### Questions not Debatable

to fix a time to reconvene

to recess

to call for the orders of the day

to close debate and vote

to take up any particular item of business

to grant leave to withdraw a report or resolution

to adjourn

to raise a question of privilege

to lay on the table

to limit or extend debate

to grant leave to speak

questions of order when no appeal has been taken, or where the presiding officer has not invited discussion



# VFW 101

## *Rules of Order Governing All Meetings*



### Debate Closing

Except by unanimous consent, no question on which debate has been closed shall be debatable further

a 2/3 vote is required to close debate



# VFW 101

## *Rules of Order Governing All Meetings*



### Debate Closing

when there is no further debate, or debate has been closed, the presiding officer shall put the question to vote

Simplified- once discussion is over vote on the motion takes place – all in favor of, all apposed and state the outcome



# VFW 101

## *Rules of Order Governing All Meetings*



Voice vote is doubted

presiding officer shall direct the vote taken by show of hands or by rising vote.

when the decision of any written secret ballot is doubted, the presiding officer shall appoint a committee of two members, one of whom shall be the adjutant, to recount the ballots and report to the presiding officer.

Ayes and noes shall be taken by roll call only when ordered by a majority vote of the body

the results shall be recorded in the minutes



# VFW 101

## *Rules of Order Governing All Meetings*



When the question is before the body the following motions shall be in order

### Privileged Motions:

- To fix a time to adjourn
- To adjourn
- To Recess
- To raise a question of Privilege
- To call for the orders of the day



# VFW 101

## *Rules of Order Governing All Meetings*



When the question is before the body the following motions shall be in order

### Subsidiary Motions:

- To lay on the table
- To close debate and vote
- To limit or extend debate
- To postpone definitely
- To commit, or refer
- To amend
- To postpone indefinitely
